Furthermore, in Italy, the historical mark WORLD JU JITSU FEDERATION (of which an official certificate is attached), is registered in co-ownership since 1990 by Mr. Clark / Bertoletti, has been regularly renewed at the Italian Patent and Trademark Office of the Ministry for Economic Development by current registration n ° 602017000014268 and valid on the national territory.

Recently, however, our European trademark has been claimed at EUIPO by Mr. Robert Hart (UK) from which we are appropriately defending ourselves, always using the tools made available by the Legislator and behaving with extreme correctness, despite the constant actions of discredit.

We would like to reiterate that our brand has complete validity in the territories of the European Union, as confirmed by the relevant legislation.

We await, therefore, the decision of the EUIPO to finally close the dispute and end these ongoing attacks.

It will be the law, in our case the EUIPO, to establish legal competences in due course.

This is what I have to say for clarity, loyalty and friendship.

Dear friends, In the last period, as you know, we have been receiving continuous attacks from Mr. Robert Hart (UK) that leads us to clarify some points that we consider important for the common activity.

Currently the Wjjf / Wjjko holds valid trademarks both at European and Italian level.

Specifically, Wjjf / Wjjko holds a registration of its European trademark deposited at the EUIPO (European Trademark Office) for more than 4 years, since 31.10.2014 in the name of Natascia Argia Bertoletti (general secretary). The trademark has been registered at No. 013044896, of which the official certificate is attached, and is valid in 28 EU countries, including currently the UK.

Hart (Royaume-Uni) qui nous amènent à clarifier certains points que nous considérons importants pour l'activité commune.

Actuellement, le Wjjf / Wjjko détient des marques valables tant au niveau européen qu'italien.

Plus précisément, la Wjjf / Wjjko détient un enregistrement de sa marque européenne auprès de l'EUIPO (Office Européen des Marques) depuis plus de 4 ans, depuis le 31.10.2014 au nom de Natascia Argia Bertoletti (secrétaire générale). Inoltre in Italia, il marchio storico WORD JU JITSU FEDERATION (di cui si allega certificato ufficiale), registrato in co-titolarietà già dal 1990 dal signor Clark/Bertoletti, è stato regolarmente rinnovato dinanzi al Ufficio Italiano Brevetti e Marchi Ministero Sviluppo Economico con attuale registrazione n° 602017000014268 e valido sul territorio nazionale.

Recentemente però il ns. marchio europeo è stato oggetto di contestazione dinanzi all'EUIPO da parte del signor Robert Hart (UK) dalle quali ci stiamo opportunamente difendendo, utilizzando sempre gli strumenti messi a dispo-

На този етап WJJF/WJJKO притежава валидна търговска марка както на европейско, така и на италианско ниво. Реално, WJJF/WJJKO притежава регистрация на своя европейска търговска марка депозирана в EUIPO (European Trademark Office) повече от четири години считано от 31.10.2014 г. регистрирана на името на Наташа Аргия Бертоletti (генерален секретар на организацията). Запазената марка е регистрирана под номер 013044896, както е приложен и официалния сертификат, и е валидна за 28 страни от ЕС, в които до този момент е и UK.

В настоящее время Wjjf / Wjjko имеет действующие логотипы, как на европейском уровне, так и на итальянском.

В частности, Wjjf / Wjjko имеет регистрацию своего европейского логотипа, депонированного в Европейском реестре логотипов EUIPO, более 4 лет назад, начиная с 31.10.2014 года, от имени Natascia Argia

Bertoletti (генеральный секретарь). Логотип зарегистрирован под номером №013044896, к которому прилагается официальный сертификат, и действует в 28 странах ЕС, в том числе на данный момент и в Великобритании.

Кроме того, в Италии исторический логотип WORD JU JITSU FEDERATION (к которому прилагается официальный сертификат), был совместно зарегистрирован в 1990 г г-ми Clark / Bertoletti и регулярно обновляется в Итальянском ведомстве по патентам и логотипам Министерством экономического развития по текущей регистрации № 602017000014268 и действует на территории страны.


